AMENDED ARTICLES OF INCORPORATION OF PNOC RENEWABLES CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, all of whom are of legal age, Filipino citizens and residents of the Philippines, have this day voluntarily associated together for the purpose of forming a corporation under the laws of the Philippines.

AND WE HEREBY CERTIFY:

ARTICLE I

The name of this corporation shall be PNOC RENEWABLES CORPORATION.

ARTICLE II

The purpose for which the corporation is formed:

PRIMARY PURPOSE

To promote and undertake research, development, utilization, manufacture, sale, marketing, distribution and commercial application of new renewable, non-conventional and environment-friendly energy sources and systems including but not limited to solar, wind, water, heat, steam, ocean, tidal, biomass, biogas, chemical, mechanical, electrical,

synthetic, agricultural, and other natural, fossil, non-fossil fuel based, artificial, organic or otherwise, and of energy systems that use new renewable and any energy resources applying new and efficient energy conversion and/or utilization technologies for commercial application and promote their efficient utilization.

AS MAY BE NECESSARY TO CARRY OUT THE FOREGOING PRIMARY PURPOSE:

- 1. To invest its funds, borrow, and receive monies and other resources and to enter into contracts such as, but not limited to energy generation and co-generation, technical assistance, patent, royalty and franchise agreements, joint ventures, service agreements, lease, build-operate-transfer agreements, etc. as may be necessary in connection with and in furtherance of its primary purpose;
- 2. To prospect, explore, dig and drill for, exploit, extract, produce, store, hold, transport, distribute, exchange, sell and otherwise dispose of import, export and trade and generally deal in any and all kinds of energy-producing substances of any nature and description and the products and by-products which may be derived, produced, prepared, developed, compounded, made or manufactured therefrom;
- 3. To develop, maintain, install, service, operate, sell, distribute, rent, franchise or convey all kinds of energy-saving mechanisms;

- 4. To establish linkages with international and local research institutions for fund generation, institutional building, information and personnel exchange training;
- 5. To engage in energy research development and demonstration activities by itself or with other research and development institutions, academic institutions and other interested parties in the development and commercialization of new and renewable energy technologies through appropriate technical, financial and institutional arrangements;
- 6. To purchase or otherwise acquire, assemble, install, construct, equip, repair, remodel, maintain, operate, hold, own, lease, rent, mortgage, charge, sell, convey or otherwise dispose of, any and all kinds of refineries, gas works, mills, factories, installations, plants, shops, laboratories, pipelines, pumping stations, tanks, repair shops, electrical works, power houses, warehouses, terminals, office buildings, and other buildings and structures, tankers and other vessels and any and all kinds of machinery apparatus, instruments, fixtures, and appliances;
- 7. To apply for, or join in applying for, purchase or by other means acquire and protect, prolong and renew, whether in the Philippines or elsewhere, any patents, patent rights, licenses, protections, concessions, inventions and processes which may appear likely to be advantageous or useful to the Company, and to use and turn to account, and to manufacture under or grant licenses or privileges in respect

of the same, and to expend money in experimenting upon and testing any patentable device or in experimenting upon and testing and in improving or seeking to improve any patents, inventions, processes or rights which the Company may acquire or proposed to acquire;

- 8. To promote any other company for the purpose of acquiring all or any of the property and or undertaking any of the liabilities of this company, or to undertake any business or options which may appear likely to assist or benefit this Company, or to enhance the value of any property or business of this Company, and to place or guarantee the placing of, underwrite, apply for, and accept, or acquire the whole or any part of the capital or securities of any such company, or to lend money or to guarantee the performance of the contracts of such Company;
- 9. To sell or otherwise dispose of, subject or according to the laws of the Philippines and or any foreign country or place where the Company is for the time being authorized to do and carry on business, and to enter into, make and execute contracts, agreements or assignments thereof, of or with reference to the whole or any part of the undertakings of the Company, either together or in portions, for such consideration as may be agreed, and in particular for shares, debentures, bonds or securities of any company purchasing the same;

- 13. To apply for, obtain, register, purchase, lease or otherwise acquire and to hold, own, use, exercise, develop, operate and introduce, and to sell, assign, grant licenses or territorial rights in respect of, or otherwise to turn to account or dispose of, any copyrights, trademarks, tradenames, brands, labels, patents or inventions, improvements or processes used in connection with or secured under letters patent of any country government or authority, or otherwise in relation to any of the purposes herein stated; to manufacture under or grant licenses or privileges in respect of the same, and to expend money in experimenting upon and testing and in improving or seeking to improve any patents, inventions, processes or rights which the Company may acquire or propose to acquire; and to acquire, use, exercise or otherwise turn to gain licenses or rights in respect of any such copyrights, trademarks, tradenames, brands, labels, patents, inventions, improvements, processes and the like;
- 14. To manufacture, purchase or otherwise acquire, and to hold, own, invest, trade and deal in, mortgage, pledge, charge, assign, sell, exchange, transfer or otherwise dispose of, goods, wares, merchandise and personal property of every class and description and to transport the same in any manner;
- 15. To merge or consolidate with any corporation heretofore and hereafter created in such manner as may be permitted by law;

- 16. To aid by subsidy or in any other manner whatsoever, in so far as may be permitted by law, any corporation or association, any shares or voting trust certificates for shares or bonds or other securities or evidences of indebtedness of which shall be held by or for the Corporation or in which, or in the welfare of which the Corporation shall have any interest; to do any acts or things designed to protect, preserve, improve or enhance the value of any such shares, voting trust certificates, bonds, or other securities or evidences of indebtedness or the property of the Corporation and in connection with any such purposes to guarantee or become surety for the performance of any obligation or undertaking of such corporation or association and to do any and all such other acts or things as may be designed to accomplish any such purpose;
- 17. To invest and deal with the moneys of the Company not immediately required in such manner as may from time to time be thought fit;
- 18. To give credit to such persons, firms or companies and on such terms as may be thought fit, and in particular to customers, persons, firms and companies dealing with the Company, and to give guaranties or become surety for such persons, firms or companies;
- 19. To borrow or raise money in such manner as the Company shall think fit, and in particular by the issue of bonds, debentures, and to secure the repayment of any

moneys borrowed or raised or owing by the Company by mortgage, deed of trust, pledge, charge, or lien upon the whole or any part of the Company's property or assets (whether present or future) and also by a similar mortgage, deed of trust, charge or lien, to secure and guarantee the performance by the Company of any obligation or liability it may undertake;

- 20. To improve, develop, exchange, let on lease or otherwise, mortgage, sell, dispose of, turn to account, grant rights and privileges in respect of, or otherwise deal with all or any part of the property and rights of the Company;
- 21. To apply for, promote, and obtain any Act of the Legislature of this Country or of any foreign or place, in which this Company may carry on business, or other authority for enabling the Company to carry out its objects or any these presents, of for any other purpose which may seem expedient;
- 22. To acquire or obtain from any government or authority, supreme, municipal, local or otherwise, or any corporation, company or person, any charter, contracts, decreed, rights, franchises, privileges and concessions which may be conducive to any of the objects of the Company, and to accept, make payments under, carry out, exercise, and comply with any such charters, contracts, decrees, rights, franchises, privileges and concessions;

- 23. To make, purchase, or otherwise acquire and hold shares or other interest in or securities of any other Company having objects altogether in part similar to those of this Company, or carry on any business which may directly or indirectly, assist any business carried on by this Company;
- 24. To acts as agents or brokers for any person, firm, or company, and to undertake and perform sub-contracts, and also to act in any of the businesses of the Company through or by means of agents, brokers, sub-contractors or others;
- 25. To effect insurances against risk of loss to the Company and to insure any servants of the Company against risk or accident in the course of their employment by the Company, and to pay premiums in respect thereof;
- 26. To support and subscribe to any charitable or public object and any institutions or club which may be for the benefit of the Company or its employees either directly or indirectly or may be connected with any town or place where the Company carries on business, and to give pensions, gratuities or charitable aid to person or persons who have served the Company, or to the wives, children or other relatives of such persons, and to form and contribute to provident and benefit funds for the benefit of any person employed by the Company;

- 27. to procure the Company to be registered or recognized or to be permitted or allowed to carry on its business or any branch, or branches thereof in any foreign country or place,
- 28. To carry out all or any part of the foregoing purposes as principal, agent, factor, contractor or otherwise, either alone or in conjunction with any other person, firm, association, corporation, municipality, country, state, province, body politic or government;
- 29. To exercise all or any of its corporate powers, rights and privileges, and to conduct its business in all or any of its branches in any part of the world, and for this purose to have and maintain and to discontinue such number of offices and agencies therein as may be convenient;
- 30. To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes or the furtherance of any of the powers herein set forth, either alone or in association with other corporations, firms or individuals, and to do every other act or acts, thing or things, incidental or pertinent, to or growing out of or connected with the foregoing purposes or powers of any part or parts thereof;

The foregoing clauses shall be construed both as purposes and powers and the purposes and powers specified in the foregoing clauses shall, except otherwise

expressed, be in no way limited or restricted by reference to o inference from the terms or any other clauses in these Articles of Incorporation, but the purposes and powers specified in each of the foregoing clauses shall be regarded as independent purposes and powers.

ARTICLE III

The principal office of the Corporation is established at G/F PNOC

Building V, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro

Manila. (Amended as of 15 December 2017)

ARTICLE IV

The term for which the Corporation is to exist is fifty (50) years or for such longer period as may hereafter authorized by the laws of the Philippines, from and after the date of incorporation.
